1. INTRODUCTION

- 1.1.1 This Transport Note (TN) has been produced in relation to a planning application submitted to North Hertfordshire District Council (NHDC) on Land West of Ashwell Road, Bygrave, Hertfordshire. The application is seeking consent for a solar farm development (App Ref: 22/00741/FP).
- 1.1.2 The current status of the application is set as 'awaiting decision', and it is subject to an Article 31 holding direction issued by The Secretary of State on 14 September 2023. This does not prevent NHDC from considering the application, and as such the applicant is seeking to provide more information to support the submission.
- 1.1.3 The local highway authority (LHA), Hertfordshire County Council (HCC), provided post-application comments, which included a recommendation for the inclusion of several conditions for consideration by North Hertfordshire District Council (NHDC) in determining the application.
- 1.1.4 This TN has been produced to address one of the recommended conditions, namely 'Condition 27', which states the following in relation to the proposed construction access:

"Prior to the commencement of the development, a revised construction access plan shall be submitted to and approved in writing by the Local Planning Authority in consultation with the Highway Authority, within the area along Ashwell Road identified on indicative plan C22028-ATP-DR-TP-009. The revised construction access plan shall include full details of access location, width, visibility splays (based on a new speed survey at this highway location), vehicle tracking diagrams, surface materials, and other associated highway design considerations. The access as approved shall be in place to the satisfaction of the Local Planning Authority before construction of the development commences and shall be the sole point of construction access at all times. The access shall be decommissioned with the highway and verges reinstated in full including a replacement boundary hedgerow as agreed pursuant to condition 12 to the satisfaction of the Local Planning Authority within three months of construction work being completed

Reason: To ensure a construction access that is safe and suitable for the highway environment and to accommodate the level and type of vehicles to use it".

- 1.1.5 As stated in the condition, indicative plan 'C22028-ATP-DR-TP-009' shows an area along Ashwell Road which the applicant has provided for a construction access, as outlined in the submitted Transport Note (Transport Note reference: C22028/TN02) produced by Apex Transport Planning Ltd. This access was requested by the LHA as an alternative to using the existing farm access located to the north of the site, during construction. In response to the submitted Transport Note, the LHA accepted the principle of an access within the vicinity of the location identified, subject to further information as outlined in Condition 27. The new access will be used by all construction vehicles entering and exiting the site.
- 1.1.6 Condition 27 also states that the access shall be decommissioned within three months of construction work being completed. Following discussions with Hertfordshire Fire and Rescue Service (HFRS) and with reference to the National Fire Chiefs Council (NFCC) guidance in relation to BESS sites, the applicant will retain the new access following construction of the site. This will ensure that there are two access points into the site for fire vehicles, in accordance with the guidance, including the existing farm access to the north.
- 1.1.7 This TN provides further information to address Condition 27, by providing a general arrangement design of a suitable access which demonstrates visibility splays in accordance with obtained traffic speed data. This demonstrates that an access in this location can be delivered and would be safe and



suitable for the proposed construction phase (as well as the ongoing operational phase). The location of the access also ensures the impact on the existing hedgerow and vegetation is minimised, although this relates to Condition 12 which is considered separately by others.

2. PROPOSED REVISED ACCESS ARRANGEMENTS

2.1 Observed Traffic Speeds

2.1.1 Two automated Traffic Count (ATC) surveys were undertaken by independent traffic survey specialist, Severnside Transportation Data Collection Ltd. The surveys collected traffic speeds along Ashwell Road over a seven day period (05/11/23 – 11/11/23) from locations within the vicinity of the proposed access location. The locations of the ATC surveys are shown in Figure 2-1.

2.1.2 A summary of the 85th percentile speeds recorded across the seven day period (unadjusted for wet weather) is set out in Table 2-1. The full speed survey outputs are provided in Appendix A.

- 2.1.3 The results show that the recorded speeds were significantly slower than the 60mph speed limit for this section of Ashwell Road (national speed limit for single carriageway roads). The 85th percentile speeds for vehicles approaching the proposed access location from the south (northbound vehicles) were recorded at 35.8mph, with 44.2mph recorded for vehicles approaching from the north (southbound vehicles).
- 2.1.4 In relation to recommended visibility splay distances, Manual for Streets (MfS2) is considered appropriate for calculating the appropriate Stopping Sight Distance (SSD) for the observed traffic speeds.
- 2.1.5 For the observed 85th percentile speeds of 35.8mph for vehicles approaching from the south, the 'below 60kph' formula has been used from MfS2 which recommends a visibility distance of 55.4m. For the observed 85th percentile speeds of 44.2mph for vehicles approaching from the north, the MfS2 'above 60kph' has been used and this recommends a visibility distance of 95m (based on absolute minimum parameters, which are considered the most appropriate to use in this location as desirable minimum parameters are based on snow and ice conditions for trunk roads).
- 2.1.6 The application of MfS2 guidance is considered appropriate for an access at this location as Ashwell Road is not a trunk road, and the access will accommodate a minimal number of movements during the temporary construction period which will be controlled through a Construction Traffic Management Plan (CTMP). Deliveries can be scheduled via a booking system, avoiding peak hours and the access can be controlled by a qualified banksperson to ensure vehicles enter and exit the site safely, if needed.

2.2 Proposed Access Arrangements

- 2.2.1 A general arrangement design of a new access, suitable for accommodating construction vehicles (and ongoing operational vehicles, as well as fire access) is included in Appendix B.
- 2.2.2 The access comprises an initial 6m wide road within the site, with an 8m radius to the south with taper and a 4m radius to the north. The larger radius has been designed to accommodate HGVs accessing and egressing the site from the south, in line with the preferred access route. The design includes a lay-by on the internal access road to enable construction vehicles (assessed as passing articulated vehicles) to pass safely and avoid the need for waiting on the highway.
- 2.2.3 Visibility for drivers emerging from the access is shown at 2.4m x 55.4m to the south and 2.4m x 95m to the north, with a 1m carriageway offset. This is in accordance with the recommended visibility distances provided in MfS2, as outlined in Section 2.1. The location of the access ensures that the recommended visibility can be achieved with minimal impact on the existing hedgerow, and the impact is mainly related to the width of the access, rather than visibility splays. Where required, the existing hedgerow and vegetation will be realigned along the site boundary at the site access location behind the visibility splays. This will ensure the visibility splays are clear of any obstructions (to a minimum height of 0.6m above ground level). The visibility splays are shown on the general arrangement design included at Appendix B.



- 2.2.4 Drivers approaching the site from both directions are also provided with appropriate forward visibility to the site access in excess of the recommended distances for the observed speeds, with approximately 150 metres possible to the south and 170m possible to the north. As such, the visibility is appropriate at this location and the proposed use.
- 2.2.5 The access will connect to the proposed development area via new permeable access tracks and temporary compounds. The access will be surfaced appropriately to accommodate construction traffic, as agreed with HCC.
- 2.2.6 The proposed access will form the only access and egress point for the site onto the highway during the temporary construction period, as agreed with the LHA and stipulated in Condition 27. As outlined in Section 3, a banksperson will be located at the access during delivery times to ensure vehicles enter and exit the site safely, if needed.
- 2.2.7 A swept path analysis exercise demonstrates that the access can accommodate up to 16.5m long articulated HGV's (the largest vehicle expected at the site) accessing and egressing the site from the south. This also ensures that the site access is suitable for accommodating smaller emergency vehicles such as fire appliances. The internal site layby enables this to occur without conflict. The swept path analysis is provided in Appendix C.

3. ADDITIONAL TRAFFIC MANAGEMENT MEASURES

- 3.1.1 An appropriately qualified banksperson will be located at the access during delivery times to manage construction movements to and from the adopted highway, preventing queuing, parking, or unloading on the highway. It is also proposed that a HGV lay-by be provided within the site (as indicated on the access drawing at Appendix B) to allow vehicles to wait whilst delivery vehicles are entering the site, and this will be managed by the qualified banksperson / people.
- 3.1.2 The deliveries to the site would be co-ordinated to avoid large numbers of vehicles arriving and departing from the site at the same time, and requiring the use of the lay-by. If required, a vehicle booking system can be implemented which manages the number of vehicles arriving and departing the site. The booking system would also be controlled by the banksperson / people, and this will further minimise the potential for any impact on the highway network. In addition, there will be just two HGV arrivals per day which will take only arrive along Bygrave Road / Ashwell Road between 09.30 and 14.30, as requested by the highway authority. This will further minimise the impact of HGV movements on the network.

4. **CONCLUSIONS**

- 4.1.1 This TN has demonstrated to the LHA that a safe and suitable access can be provided to accommodate vehicles during the construction period (and ongoing operational vehicles, as well as fire access), and provides further information to address the comments set out in the recommended Condition 27, in relation to a new access.
- 4.1.2 The proposed access and traffic management measures will ensure vehicle movements can be safely accommodated at the site access and adjacent adopted highway, and within the site itself.
- 4.1.3 As such, the site can be safely and suitably accessed from the highway and the proposals would not result in a severe impact on the capacity or operation of the highway network or an unacceptable impact on road safety. The proposals are therefore in accordance with the NPPF paragraph 111.



4.1.4 As such, based on the information provided within this TN we trust the highway authority is able to amend the recommended condition in relation to the new access.


